2. First Date of Sale:

2.1 First come first served, subject to the provisions below.

2.2 All interested persons (or their attorneys) who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale. Such persons will be grouped into three groups (each a “Group” and any person in the Group will be referred to as a “Group Participant”) according to the number of specified residential properties such persons intend to purchase for determining the order of priority in selection of specified residential properties.

Balloting will be used to determine the order of priority in selection of those specified residential properties among such Group Participants within each Group. Each such Group Participant shall be allotted with one lot. The balloting results will be announced by means as the Vendor considers appropriate at the designated venue. The Group Participants concerned will not be separately notified of the balloting results.

A Group Participant who indicated an intention to purchase two specified residential properties or three or more specified residential properties may select not more than one Selected Unit. There is no limit on the number of Selected Unit a Group Participant who indicated an intention to purchase one specified residential property may purchase.
