### 1. General provisions:

一般規定:

- 1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

- 1.2 In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting). 如有任何爭議,賣方保留最終決定權以任何方式(包括抽籤)自行分配任何指明住宅物業予任何有意欲購買的人士。

### 2. First Date of Sale:

出售首日:

- 2.1 First come first served, subject to the provisions below. 先到先得,下文另有規定除外。
- 2.2 All interested persons who are present in the additional venue as at the beginning of the Time of the Sale of the First Date of Sale (each a "Participant") will be regarded as all having come to the additional venue at the same time at the beginning of the Time of the Sale of the First Date of Sale. A Participant shall indicate the number of specified residential property(ies) that Participant intends to purchase (the "Indicated No."). A

higher priority of selection of specified residential property(ies) will be given to a Participant whose Indicated No. is larger. Where the Indicated Nos. of two or more Participants are the same, balloting will be used to determine the order of priority of selection of specified residential properties among such Participants. If a person is or is one of the persons comprising a Participant, that person may not be or be one of the persons comprising another Participant. For the purpose of illustration: (1) if a person A is a Participant, A and another person B jointly will not be regarded as another Participant; and (2) if a person A and another person B together are a Participant, neither that person A or that person B alone or with any other person(s), nor that person A and that person B together with any other person(s) will be regarded as another Participant.

於出售首日出售時間開始當時所有身處外加會場之有意認購的人士(下文稱作「參與人」)將被視作同時於出售首日出售時間開始當時到達。參與人須表明其欲購買之指明住宅物業數目(「欲購物業數目」)。欲購物業數目較多之參與人將獲較優先之揀選指明住宅物業次序。若兩名或以上參與人之欲購物業數目相同,該等參與人之間揀選指明住宅物業之優先次序將以抽籤方式決定。如一名人士為一參與人或組成一參與人之其中一人,該人士不得作為另一參與人或組成另一參與人之其中一人。舉例說明:(1)如A君為參與人,A君與B君聯名則不會被視作另一參與人;及(2)如A君與B君聯名作為一參與人,A君自己或B君自己或聯同任何其他人士,或A君及B君聯同任何其他人士均不會被視作另一參與人。

- 2.3 After the completion of balloting (if any), selection of specified residential properties shall take place. The Participants shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to paragraph 2.2 above and the result of balloting (if any), subject to the following terms: 完成抽籤程序(如有)後開始進行揀選指明住宅物業。參與人根據上文第2.2段及抽籤結果(如有)分配之順序揀選當時仍可供選擇的指明住宅物業,惟受以下條款限制:
  - The minimum number of specified residential property(ies) that a Participant must select is the Indicated No. of that Participant. Where that Participant is, for whatever reason, not able to select such minimum number of specified residential property(ies), that Participant will cease to be eligible to select any specified residential properties under this paragraph 2.3. However, when it is the turn of a Participant to select specified residential property(ies), the number of specified residential property(ies) remaining available for selection is less than the Indicated No. of that Participant, that Participant may select all such remaining specified residential property(ies) (if that Participant fails to do so for whatever reason, that Participant will cease to be eligible to select any specified residential properties under this paragraph 2.3). 參與人必須揀選之指明住宅物業數目最少為其欲購物業數目。若該參與人因 任何原因未能揀選最少該數目之指明住宅物業,該參與人即失去於本第2.3段 項下揀選任何指明住宅物業之資格。不過,若當輪到參與人揀選指明住宅物 業時,剩餘可供選擇之指明住宅物業數目少於該參與人之欲購物業數目,該 參與人可揀選所有剩餘之指明住宅物業(如該參與人因任何原因未能如此揀 選,該參與人即失去於本第2.3段項下揀選任何指明住宅物業之資格)
  - (b) Where a Participant selects any specified residential property(ies), the purchaser of that specified residential property shall only be: 當參與人揀選任何指明住宅物業,該指明住宅物業之買方只可以是:
    - (i) if the Participant comprises only one person: 如參與人只由一人組成:

- (A) the Participant; 該參與人;
- (B) one or more "Immediate Family Members" of that Participant whom that Participant requests the Vendor on spot to be purchaser(s); or 該參與人即場向賣方要求作為買方之該參與人之一位或多位「直系親屬」; 或
- (C) the Participant together with one or more "Immediate Family Members" of that Participant whom that Participant requests the Vendor on spot to add as joint purchaser(s); or 該參與人連同該參與人即場向賣方要求加入作為聯名買方之該參與人之一位或多位「直系親屬」;或
- (ii) if the Participant comprises more than one person: 如參與人由多於一人組成:
  - (A) the Participant; 該參與人;
  - (B) the Participant together with one or more "Immediate Family Members" of any individual constituting that Participant whom that Participant requests the Vendor on spot to add as joint purchaser(s); 該參與人連同該參與人即場向賣方要求加入作為聯名買方之組成該參與人之任何個人之一位或多位「直系親屬」;
  - (C) the Participant after removing any one or more individual(s) constituting that Participant who are "Immediate Family Members" of any individual constituting that Participant remaining as the purchaser or a person constituting the purchaser; or 該參與人減去任何一位或多位組成該參與人之個人(但減去之個人必須為餘下作為或組成買方之任何組成該參與人之個人之「直系親屬」);或
  - (D) where there is any removal of individual(s) from the Participant under (C) above, the purchaser may comprise the person(s) remaining after the removal together with one or more "Immediate Family Members" of any such remaining individual whom that Participant requests the Vendor on spot to add as joint purchaser(s). 當按上文(C)段於參與人中減去任何個人後,買方可以由減去後餘下之人士連同該參與人即場向賣方要求加入作為聯名買方之任何該等餘下之個人之一位或多位「直系親屬」組成。
- (c) "Immediate Family Member" of an individual means a spouse, parent, child, sibling, grandparent or grandchild of that individual Provided That relevant supporting documents to the satisfaction of the Vendor to prove the relationship have been provided.

3. On the day following the First Date of Sale and thereafter: 出售首日翌日及之後:

First come First served. Persons interested in purchasing must personally attend the designated venue. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

- (a) Prospective purchasers will be offered to view the selected specified residential property(ies), or a comparable residential property if it is not reasonably practicable for the selected specified residential property(ies) to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.
