- (a) The two (2) specified residential properties under this Sales Arrangements may only be purchased together but not individually and the purchaser of any of such specified residential properties must be the same as or must be the “Immediate Family Member” of the purchaser of the other of such specified residential properties. The preliminary deposit of each of such specified residential properties must be paid by way of cashier’s order(s).

A purchaser (“Purchaser A”) is an “Immediate Family Member” of another purchaser (“Purchaser B”) if Purchaser A or any individual comprising Purchaser A is a spouse, parent, child, sibling, grandparent or grandchild of Purchaser B or any individual comprising Purchaser B Provided That relevant supporting documents to the satisfaction of the Vendor to prove the relationship have been provided.

- (b) Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.
