- (a) The two (2) specified residential properties under this Sales Arrangements must be purchased together by either the same purchaser or a Group of Purchasers (hereinafter defined). The preliminary deposit of each of such specified residential properties must be paid by way of cashier's order(s).

- (b) Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.
